Article 1

The Università di Urbino Carlo Bo has opened the 29th Cycle of the PhD programmes for the 2013-2014 academic year. A public competitive selection is held for the admission to the following PhD programmes:

- Humanities
- Human Sciences
- Economics, Society, Law
- Sciences of Life, Healthcare and Biotechnologies
- Basic Sciences and Application

Attachment A, which is an integral part of this selection announcement, specifies, for each PhD programme, the subjects, duration, reference department, number of places and fellowships, curricula, admission exams calendar, location and any other detail.

The numbers of fellowships and places available for every Ph.D programme may be increased in the event extra funds become available before the date of the first selection test, in which case a further announcement will be published on the University web site http://www.uniurb.it/dottorati.

The official call for application and admission is published at the University of Urbino's official register (*Albo Ufficiale di Ateneo* www.uniurb.it/alboufficiale) and is also available at the website address www.uniurb.it/dottorati.

This call for application is to be considered as an official notification to all intents and purposes. Applicants will not receive any correspondence from the University. All possible variations will be available at the University of Urbino's official register (*Albo Ufficiale di Ateneo*) www.uniurb.it/alboufficiale) and at the website address www.uniurb.it/alboufficiale) and at the website address www.uniurb.it/dottorati.

The public notice of the call for application will be published on the *Gazzetta Ufficiale Serie Speciale – Concorsi Esami*, on the European website Euraxess and on the the website of the *Ministero dell'Istruzione*, *dell'Università* e *della Ricerca*.

Article 2

Requirements

The selection is open to applicants in possession of the following qualifications:

- an Italian University Degree awarded prior to the reform (Minister Decree number 509 dated 3rd November,1999, amended with Minister Decree number 270 dated 22nd October, 2004) (*Diploma di Laurea vecchio ordinamento*);
- a Master degree (laurea specialistica or magistrale)
- non-Italian degrees equivalent to the required academic qualification.

The selection is also open to candidates who will be awarded their degree by October 31, 2013. Within the call for application deadline they will have to send a self-certified transcript of all the exams taken. Failure to comply will result in exclusion from the selection.

Research grant holders ("assegnisti di ricerca" see article 22 of Law number 240/2010) can also apply, provided that their research project is consistent with the PhD programme.

Stateless applicant have the same status as Non-UE applicants.

All applicants are conditionally admitted to the selection until the verification of the qualifications required and they can, at any time, be excluded with justified provision. Applicants will be informed of their exclusion via registered mail with return receipt.

Article 3

Admission of Candidates in Possession of a Degree Awarded by a Foreign University

The selection is open to candidates in possession of an academic qualification awarded by a foreign university equivalent in duration and contents to the required Italian academic qualification. Their admission is nevertheless submitted to the Examination Board's evaluation for the sole purpose of admission to the selection procedure.

Those foreign applicants whose degree has not yet been declared as equivalent to an Italian degree have to ask for this equivalence in their application form (only to be admitted to the chosen individual PhD course). In this case, the following documentation must be enclosed:

- 1. A certified copy of the academic qualification requested, with the official translation, to be authenticated by the competent Italian diplomatic mission for the territory concerned, together with the Declaration of equivalence (*Dichiarazione di Valore*) of the qualification;
- 2. Certificate issued by the competent academic authority duly authenticated by the diplomatic/consular mission confirming the examinations passed and the number of hours of teaching required for each discipline.

The Declaration of Equivalence must indicate the final grade as well as the grading system adopted, in lack of which the minimum grade will be taken into consideration in the overall evaluation. It must also testify that the foreign academic qualification allows the admission to PhD courses in the foreign country.

Article 4 Applications

Application for the selection procedure must only be filled in online following the admission procedure at http://www.uniurb.it/studentionline by 10th September, 2013, 12,00 a.m. Access to admission procedure is submitted to system registration.

(Foreign applicants without fiscal code (*codice fiscale*) must fill in the paper form "*Domanda di ammissione*" available at www.uniurb.it/dottorati>modulistica. The same deadline applies.)

Restricted area – Registration for candidates never enrolled at the Università degli Studi di Urbino Carlo Bo:

- Select Register and fill in the required personal data. The system will generate credentials
 to be used after selecting LOGIN. After logging in, the candidate can access the restricted
 area "TEST DI AMMISSIONE" and select the chosen Phd programme.
- Restricted area Registration for candidates never enrolled at the Università degli Studi di Urbino Carlo Bo:

Candidates already enrolled at the Università degli Studi di Urbino Carlo Bo can directly "LOGIN" with their credentials (<u>username=n.surname@stud</u>; password=personal code received when enrolling).

After **logging in**, candidates have to select the degree course they last achieved so as to visualize the area "test di ammissione", and select the chosen PhD programme.

In case candidates are not any longer in possession of the credentials they can contact the Ufficio Alta Formazione , Post Laurea e Pergamene (phone +39 0722 305309-312, altaformazione@uniurb.it).

Candidates are kindly requested to apply in suitable advance. They are responsible for the correct conclusion of the procedure. No claim will be accepted regarding any system malfunction due to excessive load in proximity to the application deadline.

Applications resulting incomplete at 12.00 a,m, on 10 September 2013 will not be processed.

In compliance with Law number 104 of 1992 and subsequent amendments in Law number 17 of 1999, students with a disability may request, in the application, special equipment and extra time to complete the admission examinations. A medical certificate has to be enclosed testifying the validity of the request.

A non-refundable admission fee of 30 Euros is due.

Candidates intending to apply for more than one Phd Programme or for more than one curriculum have to submit an application for each PhD Programme or curriculum. The admission fee is due for each application.

The application form, once fully filled in, must be printed, duly signed (with the indication of the curriculum and the foreign language written by hand) along with the documentation requested and delivered to Università degli Studi di Urbino by 10th September, 2013, 12.00 a.m. by:

- Registered mail with return receipt, swift delivery service, delivery agencies, authorized courier;
- Hand.

The envelope must show the candidate personal data and the title of the chosen PhD programme and can contain only one application with the relevant documentation. Should candidates want to modify the application after the deadline they will have to apply and pay again the 30 Euros admission fee.

The documents listed hereunder must be attached to the application form:

- Copies of qualifications (see Attachment A)
- Self-certification testifying the status of research grant holder (only for research grant holders)
- Self-certified transcript (only for candidates who will be awarded their degree before October 31 2013)
- Copy of the 30 Euros admission fee payment receipt;
- copy of candidate's ID / passport;
- Copy of the residence permit (for non-UE candidates)
- Copy of the medical certificate testifying the validity of request of candidates with disability (only for disabled).

Applicants are conditionally admitted to the selection and the University reserves the right to verify that the correct information has been provided. The University may exclude a candidate from the selection at any time, should false declarations emerge.

The University declines any responsibility for lost correspondence due to incorrect addresses and postal service mistakes.

Any additional document has to be delivered within the application deadline. Documents submitted after that will not be accepted.

Article 5 Qualifications Documents

Qualification documents as to attachment A can be submitted in the following ways:

- a) In original or authenticated copy;
- b) Self-certified declaration (see articles 46-47 of the Decree of the President of the Republic number 445 of 2000) indicating the necessary references for the identification;
- c) Copy of the original together with a self-declaration in substitution of attested affidavit certifying that it is a true and faithful copy of the original.

The University reserves the right to verify the truthfulness of self-declarations.

The Selection will not assess qualifications whose identification elements are incomplete.

Qualifications may be submitted either in Italian or in English.

Documents attesting qualifications will be returned, upon the candidate's request, within 120 days following the date of publication of the merit ranking list. Within 6 months from the publication of the rankings, candidates shall undertake, at their own expense, retrieval of their own qualifications; after this period the Administration cannot be held responsible for the conservation of the candidate's qualifications.

Article 6 Entrance Examination

The admission tests will take place at the Università degli Studi di Urbino Carlo Bo as described below. The exam calendar can be found in attachment A (*Allegato A*) which is an integral part of this selection announcement. Applicants will not receive any convocation notice from the University. Candidates are invited to turn up at the office, date and time indicated in attachment A with their ID/Password. Candidates that will not turn up will be considered excluded.

The examination consists in the assessment of the qualifications and in two tests, an oral and a written one.

For the award of privately funded scholarships, the oral examination will be focused on the topic of the research project.

The admission examination is based on a comparative evaluation procedure.

During the written exam the knowledge of a foreign language might be tested, while during the oral exam the knowledge of a foreign language will surely be tested.

A score of at least 50/80 is required to qualify. A maximum of 30 scores may be awarded both to the written and the oral examination; the pass-mark for each exam is 20. A maximum of 20 scores is awarded to the qualifications assessment.

The score resulting from the qualifications assessment will be notified before the oral examination.

The final mark is given by the sum, out of 80, of the scores obtained in the written test, in the oral test and in the qualifications assessment.

Article 7 Selection Board

The members of the Selection Board for the PhD Courses admission examinations will be nominated in conformity with current regulations.

At the end of each examination the Selection Board draws up the list of the candidates examined with the relevant score obtained. The list will be posted up at the Department where the examination has taken place.

The documents relevant to the selection procedure will be transmitted to the Chancellor by the President of the Selection Board, in order to be approved and published at the Official Register of the University.

Article 8

Ranking, Admission and Enrolment Procedures

For each PhD course and curriculum the merit ranking of the candidates is approved by Chacellor Decree. The winners will be the candidates as resulting in the due ranking. The merit ranking is published on the University Official Register – www.uniurb.it/alboufficiale - and on the website at https://www.uniurb.it/dottorati.

In case of two or more candidates of equal merit, places with a fellowship will be allocated according to the evaluation of the economic situation determined under the Presidential Decree of the Council of Ministers dated 9th April, 2001 and following modifications.

The younger candidate shall prevail in the allocation of places without a fellowship.

No private information and/or communication about positions in the ranking list will be provided to applicants, being the publication of merit ranking the sole and official means of publicity. The candidates are admitted to the Course according to the ranking position and in a number equal to the number of places available.

Within **five working days** from the official publication of the ranking list, successful applicants must enroll. Only applications arrived within the term of 5 working days will be accepted.

Enrolment procedure and registration forms are available at www.uniurb.it/dottorati (see modalità di iscrizione).

In the event successful candidates abandon the Course within two months from its beginning, the remaining vacant places will be assigned to the immediately following candidates in the merit ranking list. If such candidate is beneficiary of a fellowship, he/she will not be required to pay back the installments already received. The University shall reassign the remaining part of the fellowship to another doctoral candidate ,already enrolled in the course, but without a fellowship, according to the admission ranking.

The candidate that is included in more than one ranking list will have to choose only one PhD Course. In this case, the remaining vacant places will be assigned to next lower candidates in the merit ranking list, who will be directly contacted.

For successful candidates from an extra-EU country residing abroad, once made the enrollment and paid the due deposit, the enrolment procedure is concluded by handing in a valid residence permit (only for non-EU citizens) or copy of the request made to the Police Headquarter-Immigration Office.

Article 9

Fellowships

Fellowships will be awarded in accordance with each PhD ranking. In accordance with the Italian Minister Decree dated 18th June, 2008, the amount of the fellowship is 13,638.47 Euros gross per annum – from this amount a percentage will be deducted as *INPS* (National Social Welfare

Institute) contribution paid by the doctoral student. Fellowships taxation is regulated by article 4 of the Law number 476 dated 13th August, 1984.

If there are two or more candidates of equal merit, the evaluation of their economic situation will prevail under the Presidential Decree of the Council of Ministers dated 9th April, 2001. In the event of a further equal result, the younger candidate shall prevail.

To take advantage of the fellowship, winners must be found in compliance with the following requirements:

- In accordance with article 12 of the Regulations of the PhD Courses, the use of a fellowship is compatible with other income, as long as the latter does not exceed the set ceiling figure indicated annually by the Board of Directors. For the calendar year 2014, the limit set to personal income is 15,000 Euros gross per annum.
- The PhD fellowships cannot be combined with other scholarships awarded for any purpose, except those awarded by national or international institutes which serve to supplement, with stays abroad, the educational or research activities for the fellowship holders.
- Must not have been awarded a PhD scholarship before.

The fellowship will be granted for the entire duration of the Doctoral programme and it is confirmed only in case of admission to the next course year, according to the decision of the Teaching Body.

The fellowship will be increased of 50% during authorized stays abroad. Study periods abroad cannot exceed 18 months.

The fellowship starts at the beginning of the Doctoral programme and the installments will be paid monthly.

Starting from the second year, the fellowship will have at least a 10% increase, for research activities concerning the PhD programme, in Italy and abroad. Should the student be excluded from the renewal of the fellowship, or should s/he renounce to it, the amount not being allocated will be available again for the same purposes.

Any civil servant admitted to the PhD Courses is placed, upon application and compatibly with the administrative requirements, on special leave for study reasons for the duration of the course, and where required conditions are met, he/she can benefit from fellowships. In the event of admission to a Doctoral Research course without a fellowship, or waiver of fellowship, the party concerned, while on leave, keeps their salary, pension and retirement contributions from the public institution with which he/she has an employment relationship in place.

Article 10

Rules for the Reuse/Reassignment of Fellowships and Vacant Places in the PhD Schools

If it is not possible to award fellowships funded by the University of Urbino which are not tied to a specific research project, due to a lack of qualified candidates in the corresponding ranking, for a specific Doctoral Course, the following procedure shall be adopted: the fellowships shall be awarded according to the curriculum merit ranking list of reference based on the scores obtained in the admission tests and formed by those who have been admitted without a fellowship within the same PhD course.

Article 11 Fees and Contributions Payable in order to Access and Attend Programmes

Enrolment fees amounts are different according to income brackets based on students Income Assessment (ISEE and ISPE) as shown below. Students can ask for a reduction on their enrolment fees by submitting a Certificazione Sostitutiva Unica (Unique Declaration Form) issued by CAAF.

PhD students who do not have a fellowship are required to pay a contribution according to published amounts. Contribution is established in a single installment to be paid upon enrolment and including: Regional Tax, Insurance, Booklet, Stamp Duty, Final Diploma Certificate. For the following years, enrolment fees have to be paid by 30th November.

In case of delayed payments, a default indemnity of 30 Euros will be calculated. Payments can be made at any branch of Banca Marche or through bank transfer (see article 4) by indicating the code reference 8871.

An expenses reimbursement of 20.00 Euros – stamp duty and insurance included – will be subtracted for each year of PhD Course attendance from the total amount of the fellowship.

Article 12

Beneficiaries of Scholarships from ERSU (Regional Body for Student Financial Aid)

In accordance with the Legislative Decree number 68 dated 29th March, 2012, PhD students can avail themselves of all benefits *ERSU* (Regional Body for Student Financial Aid) makes available to all students, at the same conditions. Candidates can apply for services (Scholarship, lodging at the Halls of Residence, catering service at the University canteens, etc.) by submitting their application form according to the Call for Applications published at http://www.ersurbino.marche.it where terms and conditions are published.

Article 13

PhD Student Duties

PhD students receive the status of university students.

Enrolment in a Doctoral course is incompatible with enrolment in any other PhD programme, academic course, university specialization school, Bachelor and Master degree courses, either in Italy or abroad, as indicated in the Minister Decree number 270 dated 22nd October, 2004, including *Tirocinio Formativo Attivo* (Active Internship Programme).

Doctoral candidates are responsible to follow the approved research plan and to annually present a report on the activity and research they conducted to their PhD Course Teaching Body. The Teaching Body will deliberate on candidates' progression to the following academic year based on the evaluation of their research activity.

Through the Doctoral Course Coordinator, and asking the programme tutor, PhD students may apply for study periods in Italy and abroad in order to carry out their research programme and/or to present research outcomes at scientific assemblies.

For study periods abroad exceeding 6 months, the approval of the Teaching Body is required. Shorter study periods are approved by the PhD course Coordinator.

Article 14

Tutoring and Didactics Activities

Upon authorization of the Teaching Body and excluding any fellowship increase, as part of the programme, PhD students can carry out tutoring activities for students of Bachelor and Master degree courses as well as integrated teaching activities, with a limit of 40 hours per academic year, for the first three years. Afterwards the limit of 40 hours is cancelled.

Article 15

Interruption of Studies and Forfeiture

PhD students may take a leave of absence to attend *Tirocinio Formativo Attivo* (Active Internship Programme) for maternity, illness or any other serious and documented reason, upon authorization by the Teaching Body. In case of maternity, interruption of studies is mandatory.

Should the interruption of studies be longer than 30 days the fellowship will be suspended.

The application must be submitted to *Ufficio Alta Formazione Post laurea e Pergamene*. The office will forward the application to the Teaching body for an evaluation. PhD students will have to catch up on the months of interruption at the end of the regular period of the PhD Course in order to cover the whole regular programme. In this case, fellowship owners will be awarded of the missing installments.

The PhD student can be excluded from the PhD Course for serious and documented reasons, if proposed by the Teaching Board.

Article 16

Final Examination and Award of the Qualification

The PhD qualification is awarded at the conclusion of the PhD cycle, when the final examination is passed, and after having presented a written thesis (PhD thesis) that provides a documented account of original research, conducted with certainty of method and leading to the emergence of results of sufficient academic relevance.

Article 17

Reference Regulations

All matters not included in the present announcement will be governed by the University Regulations on PhD programmes and by the relevant national laws.

Article 18

Treatment and Processing of Personal Information

In accordance with Article 13 of the Legislative Decree number 196 dated 30th June, 2003 - "Personal Data Protection Code" – the personal data supplied by the candidates are stored at the Università degli Studi di Urbino Carlo Bo – Area Processi Formativi, Ufficio Alta Formazione Post laurea e Pergamene – for purposes relating to the selection procedure and are handled electronically.

Article 19
