In Brief

I have over 40 years of developing country experience, 36 spent on tropical forests. I did a Social Anthropology PhD at the London School of Economics on labour migration in coastal East Africa. I taught Anthropology in the Universities of Newfoundland, Sussex and Goldsmith's College London (part-time) between 1975 and 1985. I also worked part-time for Oxfam in the Sudan and Kenya, developing my interest in forests, agriculture and conservation in the process. After work with Social Development Advisers at DFID, I was recruited by ODI to establish the Institute's Forest Policy and Environment Programme, and Rural Development Forestry Network.

I specialize in interdisciplinary research, with special interests in local people's forest management and conservation; in managing the relationship between biological diversity and livelihoods; and in landscape approaches to the management of forests, agriculture and water. I have worked with the World Bank, the European Commission, the Convention on Biological Diversity, the UN Development Programme, the UN Environment Programme, the UN Forum on Forests, the UN Food and Agriculture Organisation and a variety of European bilateral agencies: DFID and DEFRA in the UK, Norway, Finland, The Netherlands Sweden, Germany, Denmark and Italy. I was one of the team helping Bob Geldof to spend the money raised by Band Aid in 1985 for Ethiopia and the Sahel. I won the Society of American Foresters' Award for Outstanding Contributions to Tropical Forestry in 1994, and was on the Board of CIFOR (The Center for International Forestry Research), from 1996-2002, chairing it for three years.

From 2007-2012 I worked as PovertyTheme Lead on IUCN's 'Livelihoods and Landscapes' Strategy, working in 23 countries in which a landscape approach to management for sustainable livelihoods and biodiversity conservation wasdeveloped. As forests were increasingly addressed through their contribution to Climate Change mitigation, I also worked with IUCN's 'Towards Pro-Poor REDD' (2009-2018)and 'REDD+ Benefit-Sharing Project'(2012-2016). These programmes sought to harmonise climate change action with sustainable livelihoods and Rights-Based approaches. Geographically I have most experience in Anglophone and Francophone Africa, from the Sahel to S.Africa, and in South and South-East Asia especially Nepal and India, Indonesia, Vietnam, Lao PDR, and Thailand. I have also worked in Latin America in Bolivia, Brazil, Peru, Guyana, Guatemala and Mexico.

Between May 2018 and March 2023I led a series of climate change-related evaluations in Ethiopia, Guyana, the Republic of Congo, Mali and Niger. In 2022, for UK DEFRA, I led a team developing an analysis of key political, economic and technical issues in the Western Congo Basin, to help shape choices for its Biodiverse Landscapes Fund. Most recently, I have led an evaluation of GGGI support to Green Growth for the Government of Indonesia (May - October 2023).
