Corrado Malberti is Associate Professor of Commercial Law at University of Trento since 2015. From 2010 to 2015 he was Associate Professor of Commercial Law at University of Luxembourg, where he was also director of the Master 1 in European Law. He graduated from University of Milan in 2000. He completed an LL.M. at University of Chicago in 2005 and a Ph.D. in commercial law at Bocconi University (Milan) in 2006. Since 2008 he is notary in Milan, and since 2011 he is also chairman of the Working Group Company Law of the Council of the Notariats of the European Union. His principal research interests are national, comparative and European company law and financial market regulation. He has widely published in the fields of company law and financial market regulation in English, Italian and French.
